Business Arising from Minutes

1. Rainbow Beach erosion

No reply as yet.

Reclaimed water system is yet to be connected to the reservoir.

2 .Spooney's Beach desecration

Peter Rodgers has received a negative response from the Mayor. Council doesn't believe there is a problem based on lack of other complaints, no adverse observations by Rangers, and will take no action.

3. RBR Amenity Block mural

Council has advised that the mural will be replaced and the rebuild will include less flammable materials.

4. Reserves Master Plan

Roger, Kathy and John met with Liam Bulley and other Council officers last week. The Review has been delayed by bushfires but they are aiming to commence community consultation in April. This review is the first goal in our community plan.

The Council officers reported that planning is underway preparing for the \$104k works on the North Haven – Grant's Head walk.

5. CCAT and Community Plan

No action has occurred for many months. Sandra Wallace who led Council's contribution to CCAT has moved to another position in Council. We have written to Lucilla Marshall pointing out the community's concern about the delay and emphasising that a meeting is urgent to discuss what should be going into the 1920-21 Operating Plan.

6. Possible grant application re climate change

Ross reported that Council is reviewing its water strategy. In that review they have taken into account expected climate changes in this area and their effect on water.

The opportunity to put in a submission may be too late this time but iwe expect more will come. John noted that an effective submission would require some brainstorming among interested members.
