On Monday, 10th December, Mr Peter Besselling and Mr Tony Hayward came down to Bonny Hills for a drive and walk around our village with members of the BHPA executive, noting the points highlighted in a previously prepared briefing paper, posted on the BHPA website - http://www.bonnyhills.org.au/bhpa%20actions.html.

On the day we focussed their attention on 1) progress on the Master Plan for Rainbow Beach Reserve; 2) the state of Ocean Drive and the associated safety issues with lack of footpaths and crossings; and 3) our submission for funding for public toilets in the Hall Reserve.

They gave us a great hearing, so we can say that now they are well aware of the issues and opportunities facing Bonny Hills. The challenge from here will be to keep these before them and to ensure we get our fair share of what we all know is a limited pie. With careful planning, and a good working relationship with the new council, we are confident that real progress can be made.

The grassed parking area and driveway on the western side of the Surf Club have been greatly improved following the PMHC work detail leading up to Christmas. Area 14 Submission from the BHPA.

BHPA lodged a submission on 18 December 2102 regarding the Draft Amendment: *Port Macquarie-Hastings Development Control Plan 2011, Part 5,* area-based planning provisions for Area 14, and the accompanying draft Koala Plan of Management (KPoM). The main concerns centre around the impacts of this large development on existing infrastructure and services, as well as impacts on ecological corridors.
